



## British Judo Association Personal Accident Summary of Insurance 1 April 2022 to 31 March 2023

### Personal Accident

This provides a “no-fault” compensation for licence holders between the ages of 3 and 90\* who are injured whilst participating in an authorized / organised activity of the BJA anywhere in the world (includes direct travel to and from the activity within the UK only). Individuals who are not licence holders are not covered by this policy.

The benefits are:

Death	<b>£5,000</b>
Loss of eye(s), limb(s), hearing	<b>£50,000</b>
Permanent total disability from any and every kind**	<b>£50,000</b>
Hospitalisation	<b>£50 per full day, up to 104 weeks</b>
Convalescence (should a stay in hospital as an inpatient exceed 7 days)	<b>£200 reduced to £100 if aged over 70 years of age</b>
Emergency dental expenses	<b>Up to £750</b>
Broken bones Arm (humerus, radius, ulna, carpus, collarbone – clavicle) Skull	<b>£200</b>
Leg (femur, tibia, fibula, tarsus)	<b>£300</b>

Note: there is a £50 excess on each and every claim in respect of dental expenses.

\*Those between the age of 80-90 will only receive cover for Death, Loss of eye(s), limb(s) and hearing.

\*\*Permanent total disablement from any gainful employment or gainful occupation for which the insured person is fitted for by education training or knowledge.
